Dear Friends and Colleagues,

The New England Association of Chiefs of Police organization is the only organization that represents six states in the United States. The organization has committed itself to represent the highest standards of honesty, commitment and professionalism. I am the second Chief of Police to serve as President of NEACOP from the Springfield Vermont Police Department. Chief Melvin W Moore was Chief of Police in Springfield VT. From 1937-1947 and he served as President of NEACOP from 1942 to 1943. He left Springfield Vt. Police Department to serve as Sheriff of Windsor County from 1947-1975. To serve as President of this association is one of the highest honors one could ever have.

Although we currently do not endorse candidates for elected office, that doesn't mean we can't move forward and meet our Congressional representatives in Washington to address our concerns that affect the New England law Enforcement Community. Our voices need to be heard and this organization recognized as one to reach out to by our congressional representatives concerning law enforcement issues. I have had the opportunity on behalf of CABT, Coalition against Bigger Trucks; to go to Washington D.C. on our fight against the increase of weight and length on the bigger trucks. As a reminder the NEACOP has endorsed a resolution opposing heavier and longer trucks. (See Web page for resolution)

I have sent letters to each senator in each of the New England States opposing the idea of heavier and longer trucks.

I had the opportunity to attend Law Enforcement night at the Boston Red Sox's game on May 1, 2017 sponsored by The National Law Enforcement Officers Memorial. I met Secretary Kelly of the Home Land Security and discussed some of the drug issues law enforcement has been facing amongst other issues.

We are teaming up with Roger Williams University to offer an online course for an Associate's Degree in law enforcement for those officers that did not have the opportunity to go to college. This will allow them opportunity for future advancements. The details of this will come out in the near future. We will enter into a MOU with Roger Williams at reduced prices.

NEACOP has changed the Line of Duty death benefit requiring that 1) That you are a member of the NEACOP and 2) That the death occurred shall only be awarded to a designated family member of a law enforcement officer who has been killed in police action in the line of duty or has died as the direct and proximate result of a personal injury sustained in the line of duty. These changes will be voted on at the annual conference in September. For the cost of belonging to the NEACOP this is cheap insurance which we hope no one ever has to use, but in this line of work it can happen to anyone.

In the upcoming conference there will be Valor of Honor Awards for those brave officers who risked their lives protecting the community they serve. We also have community Policing Awards recognizing different size police department on what they have done for their communities

In closing these are a few things that have been worked on this year, with many more to follow. It will be up to the leadership of your elected officials at NEACOP to move this organization forward. In September I will be handing the reins over to Chief Ross Atstupenas of Blackstone Mass Police Department. NEACOP will be in good hands and I wish him all the success in his presidency of NEACOP.

I want to thank the elected officers of NEACOP for their support throughout the year. Many hands make the work load lighter for everyone. I especially would like to thank the Executive Director, Retired Chief John "Jack" Coyle for his assistance throughout the year. Jack has always kept the communication flowing and kept me a breast of the issues at hand. Thanks again Jack.

To me, it is commonsense that any time you add weight or length to a big truck, the operational to me, it is commonsense that any time you add weight or length to a dig cruck, the operational characteristics that lead to safety concerns become more compromised. That is, bigger trucks whether longer or heavier - have a higher potential to be less stable, leading to the increased potential for roll over and have longer stopping distances.

Accidents between two autos can be devastating and accidents involving a large truck and a much smaller passenger car, or cars, can be even more devastating. NEW ENGLAND ASSOCIATION OF CHIEFS OF POLICE Resolution Opposing Heavier and Longer Trucks

WHEREAS, the U.S. Department of Transportation (USDOT) released its Final Report WHEREAS, the U.S. Department of Transportation (USDOT) released its Final Report to Congress as part of the MAP-21 Comprehensive Truck Size and Weight Limits Study to Congress as pan of the MAT-21 Comprehensive Fruck Size and weight Limits Study and recommended that there should be no changes in current truck size and weight limits;

WHEREAS, heavier or longer tractor-trailers would further endanger motorists and our WHEREAS, neavier or ionger mactor-uniters would further endanger motorists and out colleagues who patrol the roads, and USDOT found in state testing in 2015 that heavier tractor-trailers had 47 to 400 percent higher crash rates;

WHEREAS, double-trailer trucks that are 91 feet in length, often called "Double 33s", WHEREAS, double-trainer trucks that are 91 feet in length, often canted Double 335, were also evaluated as part of the USDOT study, and this truck configuration needs 252 were asso evaluated as part of the USDO1 study, and this truck configuration needs feet to stop, which is 22 feet longer than the twin-trailer configuration operating on

WHEREAS, we know from our professional experience that heavier and longer commercial vehicles when involved in an accident increase crash severity by tending to

WHEREAS, tractor-trailers spend one-third of their travel miles on local roads and HEREAS, nactor-names spend one-unity of their dayer names on total todos and frequently travel on roads and streets adjacent to and through local municipalities;

WHEREAS, the International Association of Chiefs of Police (IACP) has a long standing policy opposing these bigger truck configurations for safety reasons and we are



IACP CRITICAL ISSUES LISTENING TOUR

In late August and early September, the IACP conducted a series of critical issue forums in eight locations throughout the United States – Boston, Massachusetts; Houston, Texas; Seattle Washington; Los Angeles, California; Denver, Colorado; Orlando, Florida; Cincinnati, Ohio; and a cross border session in Detroit, Michigan, with Ontario, Canada, participants.

While we heard about many issues – there was a common theme among all the sessions – public trust, police morale, the recruitment and retention of police officers, the expectations placed upon police agencies, and the role of public safety officials in addressing public health issues.

What became clear is the many of the core elements of these issues extend beyond the scope of traditional law enforcement operations and demonstrate how the role of police officers has evolved to include responding to and addressing the impact of broader social, medical and community-wide topics.

Given the above – and given law enforcement's regular engagement with persons affected by mental illness – IACP recently launched the **One Mind Campaign.**

The One Mind Campaign seeks to ensure successful interactions between police officers and persons affected by mental illness. To join the campaign, law enforcement agencies must commit to implementing four promising practices over a 12-36 month time frame.

FOUR STRATEGIES:

- Establish a clearly defined and sustainable partnership with one or more community mental health organizations(s)
- Develop and implement a model policy addressing police response to persons affected by mental illness
- Train and certify 100 percent of your agency's sworn officers (and selected non-sworn staff, such as dispatchers) in Mental Health First Aid for Public Safety
- Provide Crisis Intervention Team training to a minimum of 20 percent of your agency's sworn officers (and selected non-sworn staff, such as dispatchers)

The Listening sessions, where we had the opportunity to meet with more than 450 law enforcement professionals, and the association's daily interactions with law enforcement, have helped us shape our policy priorities for the 115th Congress.

POLICY PRIORITIES FOR THE 115TH CONGRESS. HIGHLIGHT A FEW OF OUR TOP PRIORITIES.

Establishment of a National Criminal Justice Commission:
 Support legislation that would form a National Criminal Justice
 Commission to conduct a comprehensive examination of all aspects of the criminal justice system and develop recommendations to address the broad range of new and emerging challenges that confront law enforcement today.

- Barriers to Access Electronic Evidence: Technologies and strategies
 that prevent law enforcement from accessing digital evidence
 when legally authorized are putting public safety at risk. Support
 legislative proposals that allow law enforcement to access digital
 communications and information pursuant to a lawful court order.
- Asset Forfeiture: As you know, the Asset Forfeiture Program enables law enforcement to deprive criminals of both the proceeds and tools of crime. The IACP opposes and proposal that eliminates or reduces the equitable sharing program.
- Task Force on Violence Against the Police. In December, after the
 most recent spate of attacks against the police, President De Lucca
 established a Task Force of IACP members to look more deeply
 at policy and operational approaches the IACP should be pursuing/
 supporting. The Task Force's first in-person meeting will occur in late
 January.
- Consensus Use of Force Policy. Since April, we have been helping lead an effort in partnership with the National Fraternal Order of Police to build a consensus use of force policy will be released in partnership with 10 other law enforcement associations.

Senator Sessions Endorsement for the US Attorney General.

The IACP has endorsed the nomination of United States Senator Jeff Sessions. The process included an in-depth discussion with the IACP Executive Board and Board of Directors – following a 45 minute in-person, discussion with the Senator and the IACP President and Executive Director/CEO.

Transition Planning. The IACP has been working hard to ensure our members' collective voice is heard with the incoming Administration. In addition to the above meeting with Senator Sessions, we have been in regular contact with the transition team to offer our thoughts and priorities. This outreach effort began with President – elect Trump's late summer responses to an IACP survey.

Upcoming Events. We are looking forward to seeing you at the IACP Annual Conference in Philadelphia from October 21 – 24. The Association will continue to focus on improving our members' experience – and build from the success of San Diego – our 3rd largest conference in IACP's history.

Membership. Our membership count as of December 31, 2016 (these are all highs for the end of calendar year – our member year concludes on June 31, 2017... where we are targeting yet another high count)?

MESSAGE FROM THE JUSTICE SYSTEM TRAINING & RESEARCH INSTITUTE

at Roger Williams University



Well into the second decade of the partnership between the Justice System Training & Research Institute at Roger Williams University and the New England Association of Chiefs of Police, the professional development of police leaders throughout the region continues in earnest. Over 3,800 officers have attended the Field Training Officer, First Line Supervisor, Mid-Management, and Executive Development courses delivered at the Institute before returning to their respective agencies well versed in contemporary supervisory and management techniques.

In support of the Institute's efforts to prepare command staff leaders throughout New England, another round of John D. Coyle Scholarships have been awarded this spring for attendance in the fall 2017 Command Training Series: Executive Development Course. The recipients for the next session are Major Joseph Razza of the Johnston Police Department (RI), Captain Ernest Lavigne of the West Warwick Police Department (RI), Lieutenant Scott Plummer of the Bedford Police Department (NH), and Sergeant Matthew Waugh of the Holliston Police Department (MA). Each of the recipients were nominated by their respective chief and selected following an evaluation of the nomination by a university review committee. Previous recipients for Coyle Scholarship since inception in 2014 were Captain Thomas Dolan, Johnston, RI, Captain Sean Perrin, Narragansett, RI, Lieutenant Angela Deneault, Jamestown, RI, Captain Kenneth Furtado, Warwick, RI, Lieutenant Anthony Harrington, Auburn, ME, Sergeant Richard Brown, West Greenwich, RI, Deputy Chief James Sullivan, Dennis, MA, Deputy Chief Christopher Young, Rockland, ME, Lieutenant David Bissonnette, Middletown, RI, and Major Frank Levesque, Johnston, RI.

As you may know, the work of the Institute occurs within the academic endeavor of the university's School of Justice Studies and its faculty of the criminal justice, legal studies, and cybersecurity programs. Last year Dean Stephanie Manzi, Ph.D., an advocate for the RWU-NEACOP partnership, returned to the faculty after over ten years in her administrative role and I would be remiss if I did not acknowledge how her support over that time enhanced the alliance. Beginning July 1, 2017 Eric Bronson, Ph.D., will assume the responsibilities as Dean of the School of Justice Studies and he is excited about joining the work of the partnership.

In addition to the professional development workshops, seminars, and courses at the university and throughout New England, the Institute plays a role in connecting the profession of policing to the accomplished faculty in the School of Justice Studies as well as the faculty to the profession. Some recent examples of those connections include Dr. Julie Coon's citizen satisfaction survey work for a municipal police department, Dr. Melissa Russano's work on interview and interrogation research and training for municipal police departments, as well as Dr. Sean Varano's and Dr. Stephanie Manzi's action oriented research addressing crime and violence in a major New England city. All of the faculty's research and teaching continue to inform the efforts of the Institute.





Connecticut's Own Blue Blood Family


Chief Louis J. Fusaro, Sr. was the Chief of Police for the City of Norwich, CT



In his five decades in policing, Chief Fusaro was very active in the law enforcement community. He has been a career long member of the Police Association of CT (PAC). He was its Local Vice President, served on the PAC Executive Board, and was elected its President. He served in that capacity for more than fifteen years. Chief Fusaro serves as a member of the Board of Directors of the CT Police Memorial Foundation. He is a past Secretary (nearly 20 years) and a member of the Executive Board of the regional Law Enforcement Council of CT (LEC). He is a Life member of the Connecticut Police Chief's Association (CPCA), having served multiple terms on its Board of Directors, and is a Past-President of CPCA and past Chairman of the CT Police Foundation. He is a Life member of the FBI National Academy Associates and the International Association of Chiefs of Police (IACP). He is also a Life member of the New England Association of Chiefs of Police (NEACOP) and continues to serve on the Board of Directors, as its Secretary, after more than sixteen years.

A Law Enforcement Legend Retires.



South Kingstown Police Chief Vincent Vespia retired November 1, 2016 after 57 years in law enforcement. Vespia replaced Chief Clinton E. Salisbury in 1981. Vespia served as project manager on the public safety headquarters that opened 1998. He joined the Rhode Island State Police after getting out of the Army 1959. He investigated a 1969 murder of a West Warwick bartender that resulted in four Coventry police officers being convicted. In 1972, he was appointed acting chief to reorganize the Coventry Police Department. He turned down an offer to become Coventry's permanent chief and returned to the state police to investigate organized crime, according to a biography released by the South Kingstown Police Department. Vespia was in the inaugural class inducted into the Rhode Island Criminal Justice Hall of Fame in 2012. Charlestown Chief Jeffrey S. Allen, who served with Vespia for 26 years, admires the endurance and resilience of his former boss. "This is not an easy job," said Allen, who hasn't been alive as long as Vespia has worked in law enforcement. Allen remembers the 2012 Hall of Fame induction, when Vespia told about stuffing his jacket with newspapers to keep warm as a motorcycle trooper and having to use pay phones to check in because they didn't have radios. Maine is one of nine states that driver's licenses won't be valid IDs for domestic flights in 2018. Residents of Kentucky, Maine, Minnesota, Missouri, Montana, Oklahoma, Pennsylvania, South Carolina and Washington will have to use alternative Id forms (passport, military ID, or permanent resident card) to pass TSA security checkpoints – even for domestic

travel. The Ids from these 9 states do not meet the federal government's minimum security standards. In order for states to pass the government's security standards, they must verify every ID applicant's identity, put anti counterfeit technology in the production of the cards and conduct background checks on those who issue driver's licenses.



May 18th in Augusta, law enforcement agencies from across Maine joined forces to honor police officers who have died in the line of duty. Dedicated on May 25, 1991, 84 names are now engraved in granite on the Law Enforcement Officer's Memorial which is located in front of the Maine State Capitol. Fifteen game wardens are on that memorial, more than any other branch of law enforcement in the State of Maine. Today's ceremony follows that of the National Law Enforcement Officers Memorial in Washington, D.C., at Judiciary Square. Each year on May 15 in Washington, D.C., all law enforcement officers who have died in the line of duty are honored. In 2016, 145 U.S. police officers died in the line of duty.

Maine Chiefs of Police Association is promoting MLEAP (Maine Law Enforcement Accreditation Program). MLEAP sets the standard for law enforcement in Maine. Over the last year, New Hampshire has been on the front lines of the nation's Opioid Crisis, which for many New Hampshire Police Chiefs, created some new and difficult challenges for their agencies on how to quickly adapt and find new solutions which went far beyond investigations and arrest. We were also asked to be part of many multidiscipline teams of stakeholders across the state in order to find new ways to create more resources for drug addicted

individuals needing help. The solutions for us varied from everything to specially trained Police Officers serving as Addiction Resource Officers to Recovery Coaches. We also started new educational programs in the schools called LEAD (Law Enforcement Against Drugs). This new model of prevention education, could help prevent the next generation of, drug addicted teens and young adults. We also will be hosting a one week LEAD certification class in the Lakes Region which would train several Officers in each agency on how to teach the material in their schools. For more on that go to; www.leaddrugs.org

Also in the last year, New Hampshire Chiefs of Police partnered with several New England McDonald's Restaurant franchise owners on a Community Police Officer recognition program to award Officers identified by their agency who went above and beyond to strengthen the relationship with their communities. The awards were presented at McDonalds restaurant's around the state and a percentage of all the food sales sold for that day, went to the Chiefs association for training and to support our charities. The new partnership was a huge success for New Hampshire Law Enforcement, their communities and McDonald's owners around the state.

It described the sergeant's death and requested that NEACOP review it to see if it meets the criteria for its line of duty death

benefit. The Ex. Director read the two-page letter into the record. After discussion, a **Motion** to approve the Death Benefit at \$2,500 was made by R. Hayes, second by P. Foley and the vote was all in favor.

A draft Amendment to the By Laws of the Association regarding the Line of Duty Death Benefit criteria was passed out by C. Reynolds the Parliamentarian and By Law Committee Chairman. After much discussion, a **Motion** was made by M. Metzler, second by P. Foley to amend the draft to add "surviving parents" if no spouse or children, and the requirement that the agency head must be an ACTIVE member of NEACOP to qualify for the benefit, all were in favor. The revised amendment is to be brought back to the Board's April meeting.

SECRETARY:

L. Fusaro indicated that a quorum was present and minutes of previous meeting and proposed new members were emailed to board members prior to the meeting for review and meeting action.

A **Motion** was made by P. Foley seconded by P. King to approve the minutes and proposed new members that included T. Cunningham added as a new Life member. Everyone voted in favor.

TREASURER:

Treasurer G. Kelley's Report; See the Handout (balance sheets and profit/loss). Treasurer G. Kelley briefed the Executive Board members on his report. He also noted that we did well financially in deferring the expenses of the Conference with registration income from the vendors.

Motion made to accept the report by M. Leonard, second by P. King – all in favor.

IACP Convention – Housing lottery will be held in February for hotels.

Medal of Valor – It was noted that, to date, there are a large number of nominees from different Depts.

Command Training Series – R. McKenna reviewed his hand out. He also said that enrollment continues to be good. Four John D. Coyle Scholarships have been awarded from 8 applications. He noted the new Dean is Eric Bronson. He and President Johnston met with Dr. Matt Kite regarding the possibility of obtaining AS/BS degrees on-line at perhaps a reduced rate for NEACOP member Depts. He said they will keep working on this matter and will report back to us.



Other Committee Reports - None.

COMMUNICATION:

Ex. Director Coyle reported that since the inception of the Line-of-Duty Death benefit we've never received a Thank You note. However, he got one from Mrs. Chris Gardner (mother) of the deceased SGT Gardner and he read it to the membership.

UNFINISHED BUSINESS:

Oversized Trucks – President Johnston proposed to sign a letter of support, as a result of the presentation at a prior meeting, which he passed out. **Motion** by R. Atstupenas, second by D. Hull to support the proposal against Oversized Trucks and letters by the President to federal representatives and senators, all voted in favor.

Proposed By-law Amendment – Previously passed out. **Motion** by P. King second by P. Fitzgerald to recommend the amendment to Article VII of the By-laws by adding Section 3; that defines the reasoning and qualifications for the line-of-duty death benefit and requires that the agency head must be an Active member of the NEACOP, to the full membership at next convention, all were in favor.

Amend Article VIII of the Bylaws by adding the following to Section 3:

The Heroic Awards Committee shall, based on a review of the circumstances, make its recommendation to the Executive Committee for the awarding of the NEACP Line of Duty death benefit. Death benefits shall only be awarded to a designated family member of a law enforcement officer who has been killed in police action in the line of duty or has died as the direct and proximate result of a personal injury sustained in the line of duty.

- (a) Eligible beneficiaries shall include, the surviving spouse; in the event there is no surviving spouse, the children; or in the event there is no surviving spouse or children, the parents.
- (b) Line of duty eligibility shall be limited to deaths resulting as the direct and proximate result of personal injury sustained:
 - (1) When officers acting in an official capacity are responding to an assigned criminal or public safety complaint or event;
 - (2) When officers are in direct or proximate interaction with a person or persons who are suspected of or are engaging in unlawful conduct; activities threatening the safety of the of the public; or activities threatening the officer.

The NEACP Line of Duty death benefit shall only be approved for payment when at the time of the precipitating event, the deceased was a sworn member of a law enforcement agency whose chief, superintendent or designated agency head was an Active Member of the New England Association of Chiefs of Police, Inc.

Upon adoption of the above, Article VIII, present Sec. 3 and 4 shall accordingly be re-numbered as Sec. 4 and 5.

NEW BUSINESS & MISCELLANEOUS: None.

ADJOURNMENT:

A **Motion** was made for Adjournment at 11:35pm by P. King and seconded by P. Fitzgerald for a working lunch. All were in favor. (no votes were taken at lunch)
