

IACP INITIATIVES DURING PRESIDENT DEKMAR'S YEAR

Police Response to Persons Affected by Mental Illness. At the IACP, we have long been hearing from our members about the challenges they face when responding to 9-1-1 calls that involve a person affected by mental illness. In the 1960s, the U.S. population was roughly 150 million, and there were more than 600,000 beds for inpatient treatment. Contrast that to the present day, where the U.S. population has more than doubled to 320 million people, but there are only about 50,000 beds available for inpatient mental health treatment – a fraction of the number of beds from over 50 years ago. The facts and incidents that confront the police in the U.S. are similar throughout the world. Recognizing this as an international issue, the IACP developed the One Mind Campaign.

The One Mind Campaign seeks to ensure successful interactions between police officers and persons affected by mental illness. To join the campaign, law enforcement agencies must commit to implementing four promising practices over a 12-36 month time frame.

- Establish a clearly defined and sustainable partnership with one or more community mental health organization(s)
- Develop and implement a model policy addressing police response to persons affected by mental illness
- Train and certify 100 percent of the agency's sworn officers (and selected non-sworn staff, such as dispatchers) in Mental Health First Aid for Public Safety
- Provide Crisis Intervention Team training to a minimum of 20 percent of the agency's sworn officers (and selected non-sworn staff, such as dispatchers)

We are pleased to share that we have over 300 agencies who have taken the pledge but have plenty of room to grow.

AT-RISK ADULTS

The global population of people aged 60 years and older will more than double, from almost one billion today to two billion in the next 30 years. A staggering 1-in-10 "At-Risk Adults" are victims of abuse, neglect and exploitation.

The IACP has received a grant from DOJ to work on this initiative. The IACP will join with key stakeholders to develop resources, including, roll call-training videos, investigative protocols and victim support services. These resources will aid officers in identifying signs of elder abuse and recognizing evidence that can protect victims of abuse, as well as help officers to effectively communicate with victims, service providers, and investigators working the cases.

TRUST

Whether dealing with terrorism in Jerusalem, cybercrime in The Hague, or traditional crime worldwide, law enforcement professionals are always dealing with people and communities. Trust between law enforcement and the citizenry it serves is the most essential element to achieving safe and resilient communities. That is why the TRUST Initiative is a priority during President Dekmar's term. An Advisory Board of global law enforcement leaders, academics, and community stakeholders will help develop resources to create a culture of trust and transparency between police officers and the communities they serve through advancing dialogue and application of modern policing concepts.

POLICY PRIORITIES FOR THE 115TH CONGRESS

Listening sessions, resolutions, input from IACP committees and sections, summits and reports, long standing policies, and decisions made by the Governing Body have helped us shape our policy priorities for the 115th Congress.

IMPORTANT ITEMS TO NOTE

Recent Meetings: On March 1, 2017, the IACP Executive Board meet with senior officials from U.S. President Trump's administration (Kellyanne Conway, Counselor to the President; Jared Kushner, Senior Advisor to the President; Thomas Bossert, Assistant to the President for Homeland Security and Counterterrorism; James Carroll, Acting Director of ONDCP; Jennifer Korn, Deputy Director for the Office of Public Liaison). Topics of discussion included, among others, the role police can play in addressing the opioid epidemic, gun violence, interactions with persons affected by mental illness, and the need for a national criminal justice commission. That same day, the IACP Executive Board also met with Attorney General Jeff Sessions. Topics of discussion included gun violence, school safety, national shortage of firearms examiners, operationalizing the recession of the Cole Memo, and the DOJ's decision to change the legal interpretation of "fugitive from justice" to only pertain to those wanted people who have crossed state lines and our concerns regarding that change.

Byrne-JAG delay: We have heard concern from IACP members regarding the delay in disbursing Byrne JAG funds. As you may be aware, DOJ was scheduled to disburse over \$257 million in Byrne JAG funds to each state and six territories in the United States. To date these funds have not been distributed. The delay is related to litigation over the new federal immigration law requirements DOJ placed on potential Byrne JAG recipients.

In response to this, IACP has worked with members of congress to request DOJ release these funds and urging DOJ to refrain from adding federal immigration compliance stipulations as a factor in receiving Byrne JAG and COPS grants. The IACP continues to advocate for the release of these important funds.

Concealed Carry Reciprocity Act. On December 6, 2017, the U.S. House of Representatives passed the Concealed Carry Reciprocity Act (H.R. 38) by a vote of 231-198. While the IACP is supportive of Second Amendment rights for all law-abiding citizens, we are opposed to the Concealed Carry Reciprocity Act. This legislation would undermine state laws that determine who is qualified to carry a concealed firearm—laws that take into account the distinctive circumstances and needs in each state—and would force states to allow individuals to carry guns who are not qualified to do so under the states' own laws.

H.R. 38, as passed by the House, also included the Fix NICS Act (H.R. 4477) that would address National Instant Criminal Background Check System (NICS) reporting failures. While the House passed bill combined measures, the Senate will still need to pass the bill individually or collectively. The IACP urges you to reach out to your Senator and express opposition to the Concealed Carry Reciprocity Act (S. 446).

RECENT CONGRESSIONAL TESTIMONY

- Chief David Rausch, General Chair of the IACP Midsize Agencies Division, testified before the House Committee on Homeland Security on World Wide Threats: Keeping America Secure in the New Age of Terror.
- Chief Will Johnson, Chair of the IACP Human And Civil Rights Committee, testified before the U.S. Senate Committee on the Judiciary on Responses to the Increase in Religious Hate Crimes.
- Immediate President De Lucca testified before the Senate Appropriations Subcommittee on Labor, Health and Human Services, Education, and Related Agencies on Mental Health Care: Examining Treatments and Services.

Resolutions: If you want to become more involved in IACP's policy development, a good way to do so is through our resolutions process. Committees, Sections, and individuals can submit resolutions. The IACP Resolutions Committee meets annually at the IACP conference to discuss all resolutions submitted, and the full IACP membership will have an opportunity to electronically vote on those resolutions following conference.

Collaborative Reform Initiative Technical Assistance Center. On March 15, 2018, Attorney General Jeff Sessions announced the launch of the Collaborative Reform Initiative Technical Assistance Center (CRI-TAC) during the IACP Division Midyear Conference in Nashville, Tennessee. The CRI-TAC brings together a coalition of the United States' top public safety organizations under the leadership of the IACP to provide tailored technical assistance to policing agencies through a \$7 million award from the Department of Justice's Office of Community Oriented Policing Services (COPS Office).

Using a "by the field, for the field" approach, the CRI-TAC supports state, local, tribal, and campus agencies through a host of methods, including training, peer-to-peer consultation, and strategic planning. These resources are designed to support agencies on a range of public safety, crime reduction, and community policing topics.

For the first time ever, the following law enforcement stakeholder organizations are working together to create a center of resources and subject matter expertise explicitly focusing on the needs of policing agencies:

- International Association of Campus Law Enforcement Administrators (IACLEA)
- International Association of Directors of Law Enforcement Standards and Training (IADLEST)

- National Association of Women Law Enforcement Executives (NAWLEE)
- National Organization of Black Law Enforcement Executives (NOBLE)
- National Tactical Officers Association (NTOA)

Enhancing the Response to Hate Crimes Advisory Committee. The IACP partnered with the Lawyers' Committee for Civil Rights Under Law (Lawyers' Committee) to form an "Enhancing the Response to Hate Crimes" Advisory Committee. The Advisory Committee includes both law enforcement and civil rights leader members from across the country. The Advisory Committee is working to develop a comprehensive action agenda for public officials, community leaders, law enforcement officers, and justice system leaders to enhance response to hate crimes.

MESSAGE FROM THE JUSTICE SYSTEM TRAINING & RESEARCH INSTITUTE

at Roger Williams University



There have been several changes at the Institute since the last newsletter. Robert W. McKenna, M.S., J.D., retired as the Director of the Institute in January of 2018. Bob continues to teach one course in the School of Justice Studies at Roger Williams University, and continues to write and administer police promotional tests for the Institute.

David E. Lambert, Ph.D. will take over as the Director for the Justice System Training & Research Institute and Assistant Dean for the school of Justice Studies on July 1st of this year. Dave was a member of the Massachusetts State Police (MSP) for 25 years, with assignments in research and planning, fire investigation, and homeland security. He formerly was the Special Projects Supervisor at the Commonwealth Fusion Center, an information sharing and intelligence-led policing initiative in the state of Massachusetts. During his planning assignment, he was responsible for writing and managing public safety grants. Dr. Lambert served on the faculty at the University of New Haven for the past five years. Dr. Lambert holds a doctorate in law, policy, and society from Northeastern University and a master's degree in criminology from Florida State University.

October will mark the fifteenth year of the partnership between the Justice System Training & Research Institute at Roger Williams University and the New England Association of Chiefs of Police, Inc. The professional development of police leaders throughout the region continues in earnest. Over 4,400 have attended the Field Training Officer, First Line Supervisor, Mid-Management, and Executive Development courses delivered at the Institute before returning to their respective agencies well versed in contemporary supervisory and management techniques.

In support of the Institute's efforts to prepare command staff leaders through New England, another round of John D. Coyle Scholarships have been awarded this spring for attendance in the fall 2018 Command Training Series: Executive Development Course. The recipients for the upcoming fall session are Lieutenant John Perry of the Norwich Police Department (CT), Captain George Potts of the Mashantucket Pequot Tribal Police (CT), Lieutenant John Brady of the Dennis Police Department (MA), and Captain Richard Norato of the Johnston Police Department (RI). Each of the recipients were nominated by their respective chief and selected following an evaluation of the

nomination by a university review committee. Previous recipients for the Coyle Scholarship since its inception in 2014 were Captain Thomas Dolan, Johnston, RI, Captain Sean Perrin, Narragansett, RI, Lieutenant Angela Deneault, Jamestown, RI, Captain Kenneth Furtado, Warwick, RI, Lieutenant Anthony Harrington, Auburn, ME, Sergeant Richard Brown, West Greenwich, RI, Deputy Chief James Sullivan, Dennis, MA, Deputy Chief Christopher Young, Rockland, ME, Lieutenant David Bissonnette, Middletown, RI, Major Frank Levesque, Johnston, RI, Major Joseph Razza, Johnston, RI, Captain Ernest Levigne, West Warwick, RI, Lieutenant Scott Plummer, Bedford, NH, and Lieutenant Ken Creutz, Ledyard, CT.

As many of you know, the work of the Institute occurs within the academic endeavors of the university's School of Justice Studies and its faculty of the criminal justice, legal studies, and cybersecurity programs. Eric Bronson, Ph.D. took over as Dean in the School of Justice Studies in July of 2017, and continues to support the work of the Institute and the partnership with the New England Association of Chiefs of Police.

In recognition of the New England Association of Chiefs of Police annual Community Policing Awards, a Community Policing Forum was conducted by the Institute and the NEACOP, bringing many of the current and former recipients in to share their successes throughout New England. We look forward to continuing this practice in the fall with a focus on the recipients of this year's Community Policing Awards recipients. In addition, the Institute through the leadership of Dr. Lambert will work with the Association to conduct a professional development needs assessment so that we are current with the needs of the region. The Institute will also open up more opportunities for police agencies throughout the region to host on-site JST&RI training.

STATEMENT BY U.S. ATTORNEY ANDREW E. LELLING REGARDING PEACE OFFICER'S MEMORIAL DAY

BOSTON - Today marks the 55th anniversary of Peace Officer's Memorial Day. It is the one day of the year when we are called upon to recognize those who preserve law and order, particularly those who

have been injured in the line of duty or who have made the ultimate sacrifice to keep our communities safe. In truth, we should be keeping our peace officers - federal agents, state troopers, police officers, probation officers, corrections officers and others - in our daily thoughts and prayers.

Being a peace officer is neither easy nor without risk. The number of firearms-related law enforcement officer fatalities is up 56% in comparison to this time last year. This is a trend that we must stop, through aggressive enforcement and by encouraging respect for the law.

Our peace officers are also at a higher risk than ever of exposure to traumatic events, resulting in a steady increase in post-traumatic stress and suicidal behavior among those who keep us safe. I cannot overemphasize the need for improved support, training and equipment for these brave men and women. The least we can do is give them the resources they need to do their jobs. While the federal government will do its part in this area, state and local government must also prioritize the safety and well-being of their officers. Local law enforcement agencies cannot bear this responsibility alone.

To the peace officers in this Commonwealth - today and every day - you have my deepest regard and admiration. The U.S. Attorney's Office supports you, respects you and has the greatest appreciation for what you do. To the families and loved ones of those who have died or been injured in the line of duty, we remember, and we will not forget the sacrifices that have been made on our behalf.

NEW HAMPSHIRE NEWS



Over the last year, NH Chiefs of Police have continued to keep their primary focus on addressing the Opioid Crisis which continues to tear at the country fabric of New Hampshire and its residents. NH Chiefs have continued to increase enforcement efforts with programs like Granite Shield, participate in countywide drug task forces, strengthen partnerships with the recovery community and finally, make significant changes in the drug prevention model in our schools.

Many of New Hampshire's Law Enforcement agencies have embraced the fairly new and innovative prevention model called LEAD or Law Enforcement Against Drugs. New Hampshire has trained over 120 Officers and dozens of teachers across the state to roll out this new initiative over the last year. Some of New Hampshire's largest cities, such as Manchester have adopted LEAD and begin the new model in the schools this fall. The feedback so far is very positive from both the students and the schools.

NH Chiefs have also been deeply involved in some very serious legislation over the last year with topics such as the attempt to repeal death penalty which was put in place for defendants convicted of killing Law Enforcement Officers. We also were involved with many other pieces of legislation which included changes to medical marijuana, decriminalization attempts, mental illness as it relates to firearm sales and possession, bail reform,1033 program, Marcy's Law, animal cruelty laws and retirement restrictions on part time hours worked. The legislation committee chaired by Chief Dave Goldstien of Franklin PD worked very hard over the last year, putting in thousands of hours at the state house to represent New Hampshire Law Enforcement.

The President, Chief Andrew Shagoury of Tuftonboro PD will serve an 18 month term as President, as the annual NH Chiefs of Police conference which is typically held in June, was permanently moved to December. It will be held at the North Conway Grand Hotel and following Chief Shagoury's term as President, Chief Mark Chase of Center Harbor will move up as President of NH Chiefs in December.

The NH Chiefs Trade Show will still be June 7th at the Radisson Expo Center in Manchester. Over 100-120 vendors attend each year and the trade show also offers some great free training breakout sessions. NH Chiefs Association Director Pat Sullivan is coordinating these events.

NEACOP Chiefs from New Hampshire have also been doing a strong campaign drive this year to recruit new members for our New England Chiefs Association. We are also assisting with the upcoming NEACOP Annual Conference in Hampton Beach this fall.

Finally, Chief Ted Smith, our SACOP representative will move up to the position of Vice Chair of SACOP at the 2018 IACP conference in October. Also Chiefs Reynolds, Cormier, Kurz and Dennis from New Hampshire all attended the IACP Midyear Conference in Atlanta to take part on the many IACP committees that we help with and represent New England.


Resigns December 31, 2018




